Nina Mendoza Recognized as One of the County's Top Employees

Nina Mendoza was recently honored as one of San Bernardino County's top employees. Mendoza says that she was very surprised when she found out she was nominated by Lieutenant Newcombe and was extremely honored to be recognized in this way.

Mendoza has been a San Bernardino County Sheriff for the past twenty years, and loves her job. She began working for San Bernardino County at the age of 25, and saw the job as fit for her because, as a single mother, stability and benefits was something she needed to help take care of her son. Years later, her 27-yearold son now works for the San Bernardino Sheriff's Department as a dispatcher. Since

the day she joined, Mendoza knew that she had made the right decision.

For the first eighteen years of her service, she worked in the Central Detention Center and the Glen Helen Rehabilitation Center. For the past two years she has been assigned to the Grand Terrace Police Station where she organizes the neighborhood watch and citizens on patrol programs as well as the crime free multihousing program which strives towards getting all the managers of apartment complexes to work together towards a common goal of crime prevention. During her time working in Grand Terrace she has also taken a large role in law enforcement and helps identify any criminal activity that takes place in condos, apartments, and mobile home parks. She also handles the red light cameras and speed trailers that monitor driving within the city of Grand Terrace. Her new assignment in Grand Terrace seems to be working well; she enjoys working with the public as opposed to working inside a jail.

Mendoza began working for San Bernardino County as a booking officer at the Central Detention Center in 1989. Shortly after mastering her tasks, she became a Sheriff Custody Specialist where she worked with the inmates involving inmate services. In this job she was required to assess all inmates' education levels, perform mock interviews, help them earn their GEDs, and assist them in getting a job after getting out of

jail by working for a felony friendly employer. She even got inmates lined up in the jails ROP programs that involved working on auto bodies, in bakeries, and taking on desktop publishing.

Grand Terrace Begins to Invest in Modernization

In efforts of proving to the redevelopment agency board that the Redevelopment Agency's Commercial Improvement Plan deserves more funding. Joyce Powers, the community and economic development director for the city of Grand Terrace, has embarked on a project to give a local shopping center on Barton Road a makeover. The shopping center is owned by Joseph Shamolian who will be required to pay for approximately ten percent of the tab for the remodel which is expected to be no more than \$100,000.

According to the Press Enterprise newspaper, the remodel will include new signs for the fifteen stores in the shopping center, a fresh coat of light blue paint, and new landscaping for the center. Officials understand that the appearance of businesses and shopping centers reflects on the entire city, not just the individual location.

While Grand Terrace is not a themed city throughout, many residents and businesses have followed in the wood-paneled exterior, however over time it has proven to be costly to take care of and the new construc-

Grant Provides for Enhancement of Fire Services

San Bernardino County Fire was recently awarded funds to recruit, train and retain Paid-Call Firefighters for the enhancement and continued service to the citizens in the remote areas of the county. Through the SAFER Grant (Staffing for Adequate Fire and Emergency Response) section of the Assistance to Firefighter Grant Program (AFG), a program supported and encouraged by Congressman Jerry Lewis and Joe Baca, leading San Bernardino's Congressional Delegation, San Bernardino County Fire was recently awarded \$532,025. This twoyear grant requires no matching funds from the County.

These funds were graciously accepted by the County Board of Supervisors at today's board meeting. "In these tough economic times, local

governments are trying to balance public safety with finite resources," stated Supervisor Neil Derry. "This money will enhance public safety at no cost to San Bernardino County taxpayers. Additionally, rapid response is essential to public safety and this award will allow us to better serve the community as we head into the heightened fire season."

In addition to enhancing the Paid-Call Firefighter Program, County Fire will focus on the Explorer Program in the recruitment phase. "These young men and women are the firefighters of the future. We need to reach out to our youth, giving them the option to explore opportunities within the fire service," stated Fire Chief Pat Dennen.

Thanks to the AFG program, San Bernardino County Fire has received close to \$1.5 million overall since 2008.

In July 2008, County Fire received \$616,896 toward a \$771,120 project to purchase state of the art driving simulators mounted on a mobile trailer. This will allow County Fire to train suppression staff in the safe and proper handling of fire apparatus in all types of terrain, weather and highway traffic conditions and situations.

In December 2008, County Fire received \$341,622 toward a \$427,027 regional grant for 44 MDCs (Mobile Data Computers). This was a regional grant applied for on behalf of

Confire and all the regional participants in the Joint Powers of Authority (San Bernardino County Fire, Colton, Loma Linda, Redlands and Rialto Fire Departments). The MDCs will be placed in the Battalion Chief vehicles and other fire vehicles to work in conjunction with the new CAD system installed by Confire earlier this year. These will be used on incidents to maintain locations and information regarding units responding to an incident.

ing and emergency response needs of fire departments and nonaffiliated emergency medical services organizations. Since 2001, AFG has helped firefighters and other first responders to obtain critically needed equipment, protective gear, emergency vehicles, training, and other resources needed to protect the public and emergency personnel from fire and related hazards.

Paid-Call Firefighter Program

The San Bernardino County Fire Department has a long and rich history involving our Paid-Call Firefighter forces within our Department. Every one of our fire districts that now makes up the County Fire Department started as a Volunteer or Paid-Call Department. As many of these communities developed into cities so did the need for those fire companies to develop into full-time all-risk fire departments.

Today, in many areas of our County, communities still cannot afford to provide for full-time firefighter response, but have citizens that still want to help in their respective community and make their hometown a safer place to live - these are our San Bernardino County Fire Department Paid-Call Firefighters. The foundational concept for these PCF companies is that these are citizen firefighters that are there to help their fellow residents within their community and within our County any time there is a need. Trained and responding many times from their own home, these firefighters come together to assist our communities against fire, accidents, and to provide emergency medical aid as needed.

Myths of the Heart

Think you know about your heart?

Your doctor may disagree. Cardiovascular medicine faculty at the University of Wisconsin School of Medicine and Public Health say they've heard plenty of myths about heart disease -and patients who believe them may be at increased risk because of the misinformation.

To shine some truth on the subject, these cardiologists have provided a quick list of some of the most common myths they encounter in patient care. Think of it as a heart reality check.

MYTH 1: "Nobody in my family has heart disease, so I'm not going to get it."

Not true, says Dr. James Stein, director of the Preventive Cardiology Program at UW Hospital and Clinics in Madison. Only 47 percent of people with heart disease have a family history of the disease—which means the other 53 percent develop it in the absence of an obvious genetic component.

"Risk factors like unhealthy

eating habits and a sedentary lifestyle predict heart disease. The presence of any risk factors increases your risk of developing heart disease," says Stein. "But not having a family history does not protect you."

MYTH 2: "I don't have high blood pressure. My bottom number has always been normal."

It's true that, when you're young, the bottom number also known as the diastolic blood pressure—is a marker of heart disease and stroke risk. But after the age of 35 or 40 years, the key number to pay attention to is the top number—also known as the systolic blood pressure.

"As you age, your arteries get stiffer, and as a result, the top number goes up and the bottom number goes down," says Stein. "Actually, a low bottom number is very danger-

Stein notes that, contrary to popular belief, increased blood pressure is not a normal part of aging. Any increase in the top number is an indication of greater risk.

MYTH 3: "My angiography showed that I have an artery with a 50 percent blockage. We just have to take care of that one spot, right?"

Unfortunately, no. Atherosclerosis--sometimes called "hardening of the arteries"-- is a diffuse disease.

"Chances are, if you have one blockage that is easy to see, you almost assuredly have blockages elsewhere that are harder to see," says Dr. Jon Keevil, a preventive cardiologist at UW Hospital and Clinics. "Unfortunately, even those can be risky for heart attacks."

MYTH 4: "I'm thin and I'm in shape. I don't have to worry about bad cholesterol."

Wrong again. Dr. Mary Zasadil, a preventive cardiologist with UW Hospital and Clinics, says that obese patients may be more likely to suffer from cholesterol issues. But, like heart disease, cholesterol is largely genetic. If your parents or relatives struggled with cholesterol, you and your primary care physician need to pay close attention to your cholesterol numbers and have them tested

frequently.

And speaking of cholesterol, Zasadil also frequently hears another head-slapper from patients:

Right ventricle

MYTH 5: "I stopped taking my cholesterol medication because my cholesterol improved. I didn't think I needed them anymore."

You need them. Cholesterol medications, including statins, aren't like antibiotics, which can be stopped once the infection has been resolved and you've completed your course.

The protective benefits of cholesterol medications disappear once a patient stops taking them, and what has gone down (a patient's cholesterol numbers) can quickly shoot back up again.

"When you stop taking your medications, your risk of a heart event increases right back to where it was before vou started taking them," says Zasadil. "That's why it's important to discuss any change in your medications with your primary care physician."

Our Friends the "Honeybee"

We all know honeybees produce honey, but there are many other facets to the honeybee which should interest anyone who likes to eat fruit, smell flowers, or enjoy a col-

orful and healthy landscape.

Although there are many types of insects that consume the nectar of flowers, only honeybees refine and concentrate the nectar to make honey. They are making honey not for you to put in your tea, but to provide food to their hives when flower nectar is unavailable, as in winter. As with most bees, they can sting when threatened. But it is only the female that is equipped with a stinger. They are extremely social -their hives can contain nearly 20,000 bees in the summer. The social network is divid-

ed into three groups: queens, drones, and workers. There's one queen per hive and her purpose is to make more bees. Drones are male and live for two months, serving only to mate with the queen. But it's the worker bees that do the heavy-lifting. They are all sterile females and this time of year, you will see them busily foraging for nectar, pollen, water and sticky resin for hive construction. If you look closely, you can see their full pollen baskets on their legs. For worker bees, use of their stinger produces immediate death.

As these worker bees are foraging, pollen sticks to the fuzzy hairs which cover their bodies. As they move from flower to flower, this pollen rubs off, fertilizing the flowers, and resulting in better fruit production. In fact,

some plants won't produce fruit at all without the help of the honeybee.

A subspecies of honeybee, the Africanized Honeybee, was originally introduced from South Africa in a researcher's attempt to produce a domestic honeybee is better adapted to the tropics. Unfortunately, the africanized honeybee is also much more aggressive when defending their nests, dubbing them the "killer bee".

Recently a mysterious sickness has affected the domestic honeybee, causing them to the leave hive and never return, which eventually kills off the entire colony. Known as Colony Collapse Disorder (CCD), it has still not been determined the exact cause of this death exodus. Parasites, viruses, stress factors and environ-

mental toxins are still under investigation as contributors to CCD.

CA Shark Danger: Not Their Jaws but Their Fins

Surfers will be out in force along the Pacific Coast as we head toward summer, and some will be thinking about sharks in the water, though experts say it's the sharks that are in danger from over-hunting.

Matt Rand, director of the Pew Environment Group, says, between 1926 and 2007, there were only 96 shark attacks in California waters and only seven were fatal.

"It's a very-rare occurrence that a shark attack actually takes place in California waters and that it's fatal. You have much better chance of dying by having a major incident with a vending machine."

Up to 70 million sharks are being killed each year in a quest for their fins, says Rand, which are a delicacy in some Asian cuisines. A management plan is needed to address the diminishing shark population, he adds.

Congress is debating a measure that would stop fisherman from killing sharks purely for their fins. One vessel was stopped recently with 32 tons of shark fin aboard, but the operators could not be prosecuted because it was not a fishing boat.






